*In addition to the above-listed fees to Spence-Chapin, clients will be responsible for additional costs to third-parties during the adoption process, including but not limited to: country/program fees of primary provider (contact your primary provider for cost estimates), training (typically \$85-\$250), professional translation of documents (typically \$40-\$75 per document), professional translator during home study interviews if family's preferred language is not English (typically \$125-\$375), child abuse clearances (typically \$0-\$20 per person per state), overnight/express delivery if requested by client (typically \$0-\$40), medical appointments (typically \$0-\$100 per person), certification of original documents such as birth certificates/marriage licenses/divorce decrees/ death certificates (typically \$0-\$25 per document), travel fees, visa fees, passport fees, court fees (contact your primary provider for cost estimates). All intercountry adoptions have USCIS fees.*
